Pursuant to 47 C.F.R. § 1.1206, the Building Owners and Managers Association, International ("BOMA"), the Institute of Real Estate Management ("IREM"), the International Council of Shopping Centers ("ICSC"), the National Apartment Association ("NAA"), the National Multi Housing Council ("NMHC"), and the National Realty Committee ("NRC"), submit this original and one copy of a letter disclosing an oral ex parte presentation in the above-captioned proceeding.

On November 26, 1996, Gerard Lavery Lederer of BOMA, Russell Riggs of IREM, Regina Brown of ICSC, Jim Arbury of NAA and NMHC, and Roger Platt of NRC met with members of the staff of the Cable Services Bureau. Bureau staff members present included Meredith Jones, William Johnson, and Rick Chessen. 
