EMERGENCY MOTION FOR CHANGE IN HEARING DATES

1. As the final act in representation of Chameleon Radio Corporation, this is to request immediate action to change the hearing dates to a time approximately 60 days from the currently scheduled dates in order to allow time for the party to secure the services of new counsel and to allow time for new counsel to prepare for the hearing. The most immediate such date is next Tuesday, January 7, 1997 and accordingly I have styled this as an emergency motion. Bureau counsel is being served by hand and Mr. Werlinger, President of Chameleon Radio Corporation, is being served by telecopier.

2. The 60-day delay will allow the party the opportunity to secure new counsel and will not unduly impact the Commission's processes or the public interest. Upon termination of the STA following release of the hearing order and denial of the stay motion in the Court of Appeals, KFCC(AM) no longer transmits from the STA location and currently transmits from the licensed location. Thus, to the extent the 60-day delay will postpone
