This letter is written pursuant to Section 1.1206(a) of the Commission's Rules. On March 11, 1997, representatives of Weigel Broadcasting Co. ("Weigel") met with Jane Mago of Commissioner Chong's office; and with Keith Larson, Saul T. Shapiro and Roy J. Stewart of the Mass Media Bureau. Also on March 11, 1997, a representative of Weigel telephoned Robert Eckhert of the Office of Engineering Technology. During each of these contacts, the need to preserve the existing broadcast service provided by Weigel's LPTV stations serving Chicago, Illinois; Milwaukee, Wisconsin; and South Bend, Indiana was discussed. A video tape of the program "The Homework Show" was provided to Commissioner Chong's office. 
