The following rules, which impose new or modified information or collection requirements, shall become effective upon approval by the Office of Management and Budget (OMB), but no sooner than January 1, 1998: 47 CFR §§ 61.42, 61.48, 69.4, 69.106, 69.111, 69.153, 69.156. Unless otherwise stated herein, all remaining provisions of this Order are effective June 15, 1997."


