

Dear Mr. Alpert:

Follows answers to the questions on page two of the above referenced document:

1. The "Brokered" station is KKAG(TV). There is no "Brokering" station per se. The agreement is between Paxson Communications Corporation and KKAG(TV)'s licensee. The licensee of station KKAG(TV) is the Kralowec Children's Family Trust. The station operates on channel 61, and the city of license is Porterville, California.

2. Fresno, 56.

3. There are no overlapping signal contours between KKAG(TV) and any station owned by Paxson Communications Corporation.

4. The LMA agreement was entered into on April 1, 1997.

5. The LMA has a two year period beginning June 1, 1997 and will end on the earlier of the FCC's approval of the pending assignment application respecting KKAG(TV) or the expiration of two years from June 1, 1997. There is an option in favor of either party to extend the agreement for an additional one year period upon expiration of the initial period.

6. The station brokers approximately 90% of its broadcast hours to the broker.

7. Neither this station nor, as far as known to this writer, Paxson Communications is affiliated with ABC, CBS, FOX, NBC, UPN or WB.

8. This station does not subscribe to Neilson rating services and, as far as this writer knows, this station does not receive a measurable audience share.
