

PUBLIC INTEREST BENEFITS RESULTING FROM ENTERING INTO THE LMA

The construction permit for KVUT(TV), Little Rock, Arkansas was originally issued by the FCC on July 7, 1987. In July, 1996, with the Station still unconstructed, the permittee entered into a series of Agreements with Paxson Communications of Little Rock-42, Inc. providing for Paxson to undertake to construct the station and lease the facilities to the permittee and, once constructed, to program the station pursuant to a Time Brokerage Agreement. The parties also entered into a Stock Purchase Agreement providing Paxson Communications with the right to eventually acquire the station. These Agreements will enable the permittee, upon grant of the pending modification application, to construct and program this long unbuilt Little Rock television station.
