PUBLIC INTEREST BENEFITS RESULTING FROM ENTERING INTO THE LMA

The Time Brokerage Agreement for KAJW(TV) was entered into on July 31, 1996, as part of multiple agreements with the permittee of KAJW(TV) in Tolleson, Arizona. The permittee entered into Construction and Lease Agreements with Paxson Communications of Phoenix-51, Inc. and a Time Brokerage Agreement which will provide Paxson with the opportunity to program the new Channel 51 Tolleson station once it is completed and on the air. These Agreements were entered into approximately 6 years after the construction permit was issued by the FCC and will enable the station, which is currently under construction, to commence broadcasting without further delay.
