- Amend the first sentence of § 36.622(a) and the second sentence of § 36.622(b) by replacing "§ 36.611(a)(8)" with "§ 36.611(h)."
- Amend § 36.631(a)-(d) by replacing every occurrence of "§ 36.611(a)(8)" with "§ 36.611(h)."
- Amend § 54.101(a) and (b) by replacing the word "Federal" with "federal."
- Amend the first sentence of § 54.303 by replacing the word "NECA" with "association."
- Amend the second sentence of § 54.303 by deleting the word "Carrier" from the phrase "projected Carrier Common Line revenue requirement" and replacing the phrase "Common Carrier Line charge" with "Carrier Common Line Charge."
- Amend the third sentence of § 54.303 by replacing the reference to "§ 69.105(b)(1)" with "§ 69.105(b)(2)" and replacing the term "fund administrator" with "Administrator."
- Amend § 54.400(a) by replacing all four occurrences of the word "subscriber" with "consumer."
- Amend the last sentence of § 54.401(d) by replacing the word "Subpart" with "subpart."

- Amend the second sentence of § 54.413(b) by replacing the word "Subpart" with "subpart."
- Amend the second sentence of § 54.500(b)(2) by replacing the term "universal service Administrator" with "Schools and Libraries Corporation."
- Amend § 54.501(b)(1) by replacing the reference to "paragraphs (a)(2) or (a)(3)" with "paragraphs (b)(2) or (b)(3)."
- Amend § 54.501(c)(1) by replacing the reference to "paragraphs (b)(2) or (b)(3)" with "paragraphs (c)(2) or (c)(3)."
