

550-AM, ("Petitioner"), permittee of Station WGCX(FM), Channel 239A at East Brewton, Alabama, by their counsel, respectfully submits their Comments in the above captioned proceeding seeking to amend the FM Table of Allotments by substituting Channel 239C3 for Channel 239A at East Brewton, the reallocation of Channel 239C3 to Navarre, Florida and the modification of its authorization accordingly.

In support of these changes in the FM Table of Allotments and to address questions presented in the Commission's Notice of Proposed Rule Making in this proceeding, the following information is respectfully submitted:

1. The Petitioner incorporates by reference the information set forth in their original Petition for Rule Making.

2. Petitioner restates its intention to file an application seeking to modify its outstanding construction permit covering the requested facility changes for Station WGCX(FM) if Channel 239C3 is

reallotted to Navarre. Upon the grant of the application seeking a modification of the outstanding construction permit, the Petitioner will promptly construct Station WGCX(FM).

3. As part of the Commission's Notice of Proposed Rule Making ("**NPRM**") in this proceeding, the Commission asked the Petitioner to provide additional information relating to the community of Navarre. These Comments supply the information requested in the **NPRM**.

4. In an effort to answer the Commission's questions concerning the community of Navarre, and its being a community with the indicia needed for allotment purposes, the Petitioner provides within these comments as exhibits a large amount of material which shows conclusively that the community, although not incorporated, easily meets the Commission's threshold for allotment. The material provided was obtained from the area Chamber of Commerce as well as numerous publications provided to the public. The Petitioner also has provided in these Comments pictures of some of the area businesses and other entities found in Navarre.

5. First, it must be stated that in almost any other state Navarre would be an incorporated community. The Florida state legislature some years ago, due to the state's explosive growth made it almost impossible for new communities to incorporate. The state was attempting to stop what was already appearing to be a patchwork of small incorporated communities, each with different governmental entities that created their own zoning, water use, and building codes. Furthermore, each of these small incorporated

communities would have to provide their residents with the usual public services of police, fire and garbage pick up. The state legislature found that the disparities between the codes enacted and level of public services provided by these small incorporated communities was creating a nightmare on many fronts. A good example of the problem is the area between West Palm Beach and Miami which is made up of many small incorporated communities. In this area the communities are so small, sometimes just a few blocks in size, it is difficult to tell when you leave one jurisdiction and enter another. To avoid the further "balkanization" of the state, the legislature enacted laws which made it extremely difficult to incorporate a new community. The aim of this effort was to bring some sort of continuity to zoning, water use and building codes and the level and quality of service to the public. Today high growth unincorporated areas are being annexed by nearby existing incorporated communities or remain under the jurisdiction of the county in which they are located. The explosive growth in the Navarre area has taken place long after the state enacted this legislation. The problem along Florida's east coast would show up to a lesser extent in the Navarre area if Navarre and the adjacent communities of Navarre Beach, Woodlawn Beach, and Holley were allowed to incorporate individually. This is the reason why Navarre remains unincorporated.

6. Attached as Exhibit 1 is a portion of a map provided by the chamber of commerce where what would be considered the community of Navarre is outlined in heavy black marker. The

enclosed area does not include the communities of Holley, Navarre Beach and Woodlawn Beach. These three communities look to Navarre as their local retail and trading center.

7. Attached as Exhibit 2 is a membership list for the Navarre area chamber of commerce. As can be seen, most of the businesses on the list are located in Navarre and obviously provide service to the local area. It must be noted that the list includes local certified public accountants, attorneys, banks, grocery stores, newspaper, parent teacher associations for schools, restaurants, realtors and shopping centers. In addition to the list, you will find the local Elks Lodge, Friends of Navarre Library, Navarre Youth Sports Association, Holley-Navarre Senior Association, Navarre High School, and the local Cub Scout Pack. Also shown on Exhibit 1 is the Navarre Sports Complex, Bill Pullum Sports Complex and Hidden Creek Golf Course all providing services to the residents of Navarre. In the additional material presented in Exhibit 4 you will see information about the Navarre Nature Walk and the Navarre YMCA. It is self evident, that with the majority of the businesses on the chamber's membership list having Navarre address, and the community being the only retail area between the Pensacola and Fort Walton Beach urbanized areas, that the local businesses situated in Navarre intend to serve that specific community. For example, Regions Bank, First National Bank of Florida, First National Bank & Trust, Winn-Dixie Food Store, McDonalds, Burger King, Kentucky Fried Chicken, Olive Garden and Taco Bell would not have located in Navarre if those businesses

sought to attract customers from Pensacola or Fort Walton Beach.

8. Exhibit 3 provides additional material on Navarre including the population, history and general information about the community. The material states that "There are 17,000 Navarre residents..." The same material attributes an additional 1,000 homeowners to Navarre Beach and an "in season" population of 2,000 residents. The year round residents of Navarre Beach are minimal and not included in the Navarre population count. As with all areas along the Florida Gulf Coast, Navarre and surrounding area will continue to grow at a rapid pace.

9. Exhibit 4 includes photographs taken by the Petitioner which show certain aspects of Navarre including a photo of the new post office. These photos also show proof of Navarre High School, Navarre Lumber, Navarre News (local newspaper), Taco Bell, Navarre Community Center and Public Library, Soundside Office Plaza and related businesses and the chamber of commerce. The Gulf Breeze Post Office no longer serves Navarre and surrounding area. In fact, Navarre, as shown in Exhibit 1, has its own zip code, "32566".

10. In sum, it is abundantly clear that Navarre is an identifiable community for allotment purposes with all the indicia found in a vibrant incorporated community, and with the growth that it has experienced over the past decade expected to continue in the foreseeable future, is in great need of a channel allotment.


**NOW THEREFORE**, based upon the foregoing, 550-AM requests that the Commission modify the FM Table of Allotments to reallocate Channel





