On behalf of Liberman Television, Inc. ("LTI"), the owner of KRCA(TV), Riverside, California, the undersigned are hereby filing this letter with the Commission in accord with 47 C.F.R. § 1.1206(a). On January 13, 1998, at 1:30 p.m., Joseph Davis of Cavell, Mertz & Perryman and the undersigned counsel met with Bruce A. Franca of the Office of Engineering & Technology and Gordon W. Godfrey of the Mass Media Bureau. Chris Buchanan, Chief Engineer of KRCA, participated in the meeting by phone.

LTI's representatives discussed its recent acquisition on January 6, 1998 of KRCA and its concerns about the assignment of DTV channel 69 to KRCA in the Sixth Report & Order in the above-referenced docket. Alternative DTV allotments that would allow KRCA to move its transmitter site to Mt. Wilson also were discussed, including technical and procedural issues associated with possible revisions of KRCA's DTV and NTSC channel allocations.


