**COMMENTS**

East Arkansas Broadcasters, Inc., by its attorneys, pursuant to Notice of Proposed Rule Making, DA 98-177, released February 6, 1998 ("NPRM"), hereby submits its comments in support of the reallocation of Channel 272C2 from Brinkley to Colt, Arkansas and the modification of the authorization for KQMC-FM to specify operation on Channel 272C2 at Colt, Arkansas.<sup>1/</sup> In support thereof, the following is submitted:

1. East Arkansas Broadcasters, Inc. hereby incorporates its July 8, 1997 Petition for Rule Making in support of the proposed reallocation. East Arkansas Broadcasters, Inc. also restates its present intention to apply for Channel 272C2 at Colt, Arkansas when allotted, and when authorized, to build a station promptly.
