^{1/} See File Nos. BALCT-970603IA, BAL-970603IB, BALH-970603IC, BALH-970603ID and BALTVL-970603IE. PressCom initially proposed to acquire Press's licenses directly from Press. Because of unanticipated delays in the grant of those applications, Press assigned the licenses to P & LFT, LLC as an interim measure in October, 1997. Since the ownership of Press and P & LFT, LLC was identical, this interim assignment was pro forma. In January, 1998, the Video Services Division approved the assignment of the licenses from P & LFT, LLC to PressCom.
