Pursuant to Section 1.1206 of the Federal Communications Commission's ("Commission") rules, 47 C.F.R. § 1.1206, this letter will notify you that representatives of Lockheed Martin IMS ("LMIMS"), Joseph Franlin, Robert Poulin, Michael Dorrian, Audrey Herrel, and the undersigned, met on Wednesday, July 8, 1998 with representatives of the Competitive Pricing Division of the Common Carrier Bureau including, Jane Jackson, Lenworth Smith, Neil Fried, and Rhonda J. Lien.

During the meeting, LMIMS provided a general overview of the process by which limited liability companies ("LLCs") in the seven local number portability ("LNP") regions and LMIMS negotiated contractual arrangements for the provision of LNP. In addition, LMIMS sought clarification on the data collection and audit procedures identified in the Commission's *Third Report and Order* in the above-referenced proceeding. LMIMS also discussed billing and collection procedures for shared LNP costs.
