



Dear Mr. Secretary:

I am writing to you in support of **RM-9242** and the "50-Mile Rule."

Commercial radio obviously plays an important role in the community and serves many listeners. Because of their profit constraints, however, they must necessarily focus on programming that serves very large segments of the market.

Many smaller segments of the market, by the very nature of the business, easily go without much service. This is especially true for things like discussion of local issues, local culture, perhaps programming for some local minority communities, and other items of local interest. This is also true for some non-local programming, such as jazz, which simply does not have as large a following. It is very unlikely that large corporations -- especially if they are headquartered at a distance -- would be inclined or even able to respond to these needs.

Locally owned and operated stations, however, are sometimes able to operate on a smaller budget, perhaps drawing upon volunteer support from the local community, and therefore, are much more able to serve some of these local and/or less popular interests.

Again, the commercial stations are very important, but with this proposed regulation change, the FCC has an opportunity to meet some **ADDITIONAL** needs, which for many people may be equally important, and that are not met well by the commercial stations.

I very much hope that you will act favorably upon **RM-9242** which contains the 50-Mile Rule. I think it will greatly add to the breadth of the needs that are met and to the richness of the content on our public airways.

Reply-Comments of Robert N McCord

In the question of Petition **RM-9242**: There are numerous examples of the need for this critical community service across the Country. My comments will be limited to what one might consider a quintessential example of this need.

I am a thirty five year broadcaster who has been employed in all facets of the radio industry, including ownership. After living in Laguna Beach, California for the past eight years it has become dramatically apparent that a distinctively local radio service is needed. The fires of '93, which destroyed over 400 homes, forged a premier example of the urgent necessity for first hand Community information. During the firestorm the stations from LA were here in their helicopters, but the coverage was focused on the fire's sensational value rather than the dissemination of critical information the people of Laguna Beach desperately needed. They didn't know the territory. Confused street names, and out-of-place geographic references. Certainly there was endless general information. What was lacking were the indigenous specifics so vital to the local Community in a disaster like this.

Since the fires we have experienced torrential rains and attendant mudslides. Lives were lost. Through it all, immediate communication was non-existent. We learn nothing in this community on a "instant" basis. Laguna Beach is a city of 25,000 people. If this were the mid-west there would be three stations here, at least, but as a result of the powerful Los Angeles stations, we are too small in the overall scheme to swing ratings for more diligent coverage by these broadcasting monoliths. Now with the potential advent of Low Power FM the large radio voices are screaming infringement on their territory?

Only three access routes serve the City of Laguna Beach. When there is a closure, we don't know about it. During the fires, people sat in their cars for hours trying to evacuate the City, with no information from their radios. There is nowhere to turn. Phones to both City and emergency officials are bottlenecked.

The area of Laguna Beach is surrounded by hills, a virtual escarpment. Signal penetration from other Cities is sketchy. A low power service that would attend to the needs of its residents exclusively would not infringe on adjacent signals.

The term "diversity", with respect to radio, has been used in various contexts. The National Association of Broadcasters currently uses the term as it applies to radio formats or the genre of music that each station plays. They contend that in light of consolidation of ownership where the few own many, that varying formats are more readily available. Logically, the real meaning of diversity can not be mistaken. Diversity of ownership is the true measure of the term. Americans should have the opportunity to be exposed to the widest possible range of opinions. This can only stem from diverse ownership. Meanwhile, as galloping consolidation continues the need for new voices becomes greater. Low Power FM will introduce not merely recycled concepts from corporate head offices located elsewhere, but will establish locally domiciled broadcast interests, providing diversity in programming concepts, and fresh new initiatives aimed exclusively at the small markets they are licensed to serve.

No one will get rich operating a small radio station in Laguna Beach. This is a bedroom community with affluent residents who derive their income outside of the City confines. Retail trade would probably pay for the cost of operation, but my estimates of potential income are not glowing.
