Dear Ms. Salas:

On July 24, 1998, George Vradenburg, III (Senior Vice President and General Counsel), Steven Teplitz (Senior Counsel - Law and Public Policy) of America Online, Inc. ("AOL"), and I met with Kathryn C. Brown (Chief, Common Carrier Bureau), Blaise Scinto, Elizabeth Nightengale, Ed Krachner and Don Stockdale, all of the Common Carrier Bureau, to discuss broadband deployment issues in connection with the above-referenced dockets. Specifically, AOL requested that the Commission ensure that its actions promote the opportunity for competitive choice for ISPs among multiple providers of DSL broadband service and urged the Commission to consider potential anticompetitive conduct that could impair the ability of ISPs unaffiliated with incumbent carriers to offer and use such services. In addition, AOL urged the Commission to weigh fully the ramifications of altering its current position regarding the jurisdictional regulatory treatment of ISP traffic, including in connection with reciprocal compensation issues and DSL service issues.


