Dear Ms. Dortch:

On September 25, 2014, at the request of Commission staff, the undersigned provided a copy of a complaint filed by Peerless Network, Inc. (“Peerless”) and its subsidiaries against MCI Communications Services, Inc., Verizon Services Corp. and Verizon Select Services, Inc. to Victoria Goldberg, Rhonda Lien and Thomas Parisi in the Wireline Competition Bureau. The complaint was filed on September 23, 2014 in the United States District Court for the Northern District of Illinois and is available in Docket No. 1:14-cv-07417.¹ Ms. Lien requested a copy of the complaint in advance of an upcoming meeting scheduled for September 29, 2014 between FCC staff and representatives of Peerless to discuss issues related to intercarrier compensation.
