This includes High Cost Loop Support, Local Switching Support, Interstate Access Support, Interstate Common Line Support, Safety Net Additive, Safety Valve Support, Frozen High Cost Support, Incremental Support, Intercarrier Compensation Support, and Mobility Fund.


