CONCISE, SPECIFIC OBJECTIONS TO THE REPORT AND RECOMMENDATION OF THE MAGISTRATE JUDGE


The Report and Recommendation of (Doc 32) is arbitrary, counter to the rule of law, and endorses misunderstandings of both U.S. and Arkansas laws. The Report and Recommendation encourages continuing to upset the honorable "Rule of Law" like was begun accidentally with (Doc 22) by Honorable Timothy L. Brooks. Jury trials, once a guaranteed right for serious civil disputes like this, are apparently no longer guaranteed by the "Bill of Rights" in this United States District Court.

The personal bias seen in (Doc 32) began after Plaintiff's failure to continually maintain pleasing tenor in the past to avoid personal judicial bias in this District Court. The Report and Recommendation, (Doc 32), is a fiat endorsing the legal mistakes found in (Doc 22) and cites no applicable "law of the case" and treats the appealed order as precedential or authoritative and cites (Doc 22) to justify denying an "IFP" appeal of the legal mistakes in (Doc 22) itself.


