On October 23, 2014, the undersigned, along with Mr. Richard Bilotti, Portfolio Manager for Special Situations for P. Schoenfeld Asset Management LP; Mr. Joshua Weiner, analyst for Foxhaven Asset Management, LP; and Mr. David Murphy, portfolio manager for Soros Fund Management LLC, met with Philip Verveer, Senior Counsel to Chairman Tom Wheeler, and Daniel Alvarez, Legal Advisor for Wireline, Public Safety, and Homeland Security Issues to Chairman Tom Wheeler.

In particular, the parties discussed the market effects of expanding the regulatory definition of a "multichannel video programming distributor," the evolution of broadband networks and usage based billing, and potential technical constraints and market effects associated with the growth of managed (specialized) services.


