
**JOINT REQUEST FOR EXTENSION OF TIME**

By *Patrick Sullivan, et al.*, Orders, FCC 14M-21 (ALJ, rel. June 25, 2014), and FCC 14M-35 (ALJ, rel. Nov. 20, 2014), the Presiding Judge directed the parties in this proceeding to jointly file a report on or before December 1, 2014 on the status of their trial preparations and their negotiations concerning the appropriate scope of discovery. In addition, the parties were instructed to identify the manner in which they believe the issues set for hearing may be impacted by holdings in the Commission's recent *Decision in David Titus*, FCC 14-177, EB Docket No. 07-13 (rel. Nov. 6, 2014).

The parties have conferred about these matters but believe that they cannot draft, review, coordinate, and file with the Presiding Judge the results of their efforts by December 1. Therefore, they respectfully request that the time to file the next Joint Status Report be extended for one week up to and including Monday, December 8, 2014.

The Enforcement Bureau has authorized undersigned counsel to state that it concurs in this request.


