Pursuant to Section 64.1120(e)(1) of the Commission's Rules, Yeoman Telephone Company, Inc. ("YTCL"), provides notice that on or around December 31, 2014, it will transfer the subscriber base of Yeoman Communications Co. ("YCC"), and will become the long distance provider for those customers who are currently served by YCC.¹ The customers of YCC will become customers of YTCL, except for those subscribers who exercise their right to select another long distance provider.

YTCL certifies that on or about November 25, 2014, it provided advanced subscriber notice in accordance with Section 64.1120(e)(3), and that it will comply with the obligations specified in that section and all other applicable and Commission requirements. A copy of the notice is attached.

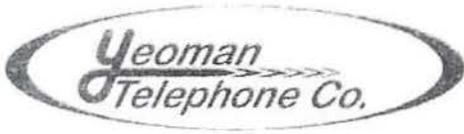

¹ YTCL will be accomplishing this transfer as part of an overall corporate reorganization where YCC, which is currently wholly-owned by YTCL, will be merged into YTCL with no change in control of YTCL. YCC provides intrastate, interstate and international long distance services to end user subscribers, which will continue to be provided by a separate corporate division of YTCL under the same terms and conditions pursuant to which YCC's subscribers currently receive service.

Yeoman Telephone Company, Inc. ("YTCI") is pleased to announce its plan to merge its wholly-owned subsidiary, Yeoman Communications Co. ("YCC"), into YTCI. The merger is planned to occur on or around December 31, 2014. YTCI believes that this action will improve the process by which our telecommunications services are provided. As a result, on or around December 31, 2014, YTCI will become your presubscribed long distance service provider for your domestic (interstate and intrastate) and international long distance services.

Our commitment to provide you with quality long distance services will continue. Prior to and immediately following the transfer, you will continue to receive the same long distance services at the same rates, terms, and conditions as you do now. Notice of any future changes in rates, terms, and conditions of service will be provided to you as required by law. Service will continue without interruption. You will incur no carrier change charges as a result of this transaction.

If you want to subscribe to a different long distance carrier before December 31, 2014 and such carrier is available, you are entitled to do so. Please contact our customer service at 574-965-2100 (which is a toll free local call) to make any such change. If you decide to change your long distance carrier before December 31, 2014, YTCI will be responsible for any carrier change charges associated with that change. Absent hearing from you before December 31, 2014, your long distance service account will automatically be transferred to YTCI on the date that the merger occurs.

Please note that YTCI will be responsible for addressing any complaints you may have regarding services provided by it on and after December 31, 2014, as well as complaints that arise prior to that date with respect to the long distance services provided by YCC.
