NOTICE TO COURT AND ALL PARTIES

Curtis J. Neeley Jr. hereby gives notice to a very busy Eighth Circuit Court and all parties along with anyone on Earth with access to common carrier wires either directly or indirectly using integrated, interconnected wire and radio communication networks often called an “interactive or interconnected network” using the common term of [sic] “Internet”. The Appearance PDF entered for Curtis J. Neeley Jr. contained live LINKS to searches that remain LINKS to be ignored by clerks or judges by their own personal choices as was the case with EVERY document filed herein.

Curtis J. Neeley Jr. communicated with Commissioner Michael O'Rielly's administrative assistant, Robert Bukowski, and inquired as to why the Federal Communications Commission modified the submitted PDFs such that links were removed and text became binary data and could no longer be copied. Mr. Bukowski was not aware of why this was done.

Mr. Bukowski was attentive and inquired with ECFS staff and was advised "LINKS were not supported". This actually meant the well-meaning FCC staff had no understanding of the fact that ECFS removal of LINKS actually meant "links not allowed" rather than "links not supported" and resulted in violations of communications law.

Curtis J. Neeley Jr. communicated with ECFS staff personally and asked if installed links might not be removed and was advised LINKS were not supported and were always ignored by FCC Commissioners because "*of the changing nature of the web*" or another guess-type reply revealing an inability to communicate with adequate intellect to assist Curtis J. Neeley Jr.

Plaintiff/Appellant has currently filed the comments attached as Exhibit "LINKS" that were made into PDFs with live LINKs by the FCC ECFS express process automatically and was done in order for the public to see how this pursuit of justice resolves.
