

Maritime Communications/Land Mobile, LLC (“Maritime”) filed a Report on Status of License Cancellations and Deletions (“Report”), with accompanying Conditional Motion for Leave, on December 5, 2014. For purposes of this proceeding, the Presiding Judge believes that Maritime provided an adequate status report on these matters at the Evidence Admission Session of November 4, 2014. Nonetheless, as the Report is merely a status report that requests no relief, the Conditional Motion for Leave is granted and the Report is accepted.

The licenses in question have been deemed to have automatically terminated.<sup>1</sup> The logistics of the removal of terminated licenses from the Commission's Universal Licensing System ("ULS") have no bearing on the issues that remain to be decided in this proceeding.<sup>2</sup> Accordingly, future filings on the ULS status of those licenses are prohibited in this proceeding. Any such filings should be made with the appropriate bureau. As the Report does not call for a responsive pleadings and the Presiding Judge does not believe one is required, no replies will be permitted.
