Exemption

Dear Sir or Madam:

I am writing in response to your email request dated December 8, 2014 for supplemental information concerning my Petition for an exemption from the closed captioning requirement for the television program "Live with Passion!" As a vowed religious and the founder of Father Cedric Pisegna Ministries (FCPM), I am providing the following additional information so that the FCC may complete its consideration of my Petition:

- (1) **Statement of Correction** – In my Petition supplement letter dated October 25, 2013, I incorrectly stated the number of previously recorded programs of "Live with Passion!" for which I am requesting exemption from closed captioning. In that letter, I stated the number of previously recorded programs was 158. The correct number of programs for which I am seeking exemption is 157, and these programs are listed in Appendix A to my October 25, 2013 Petition supplement.
- (2) **Cost of Captioning Services** – In my Petition supplement letter dated October 25, 2013, I included three rate quotes for closed captioning the "Live with Passion!" programs in Exhibit B. As requested, I am enclosing two revised, recent quotes with this letter. A denial of my Petition for an exemption from closed captioning would compel FCPM to closed caption all 157 previously recorded episodes and to redistribute the newly captioned master copies of those programs to all stations currently airing them. Utilizing the lower of the two rate quotes obtained, the cost to FCPM of a denial of a closed captioning exemption for the 157 previously recorded programs is \$376,445.
- (3) **Affidavit** – As requested, my signed and notarized affidavit is attached to this submission.

In sum, I respectfully request that FCPM be granted an exemption from closed captioning the 157 episodes of the television program "Live with Passion!" that were recorded prior to 2013.


