16 The government through its corrections administration, has
17 severely obstructed my access to lawyer's, family, friends, and
18 associate's by entering into contract's with their associates
19 (phone companies that pay them) for absolute monopoly over their
20 entire system (state wide).

21 They demand that before i'm allowed to make a phone call,
22 anyone I wish to contact must establish an individual and
23 separate contract with their associates (GTL-?) in addition to
24 what they may already have. This service must be paid in advance
25 or established before I can make or they can receive a phone call.
26 I cannot just pick up the phone and call an attorney collect, or
27 use a (1-800) number without being subjected to, or having my
28 lawyer's and family subjected to excessive penalties, or

1 punishment without due process of Federal Constitutional laws.

2 My mother is in her late eighties, early nineties, and does
3 possess the assistance or funds demanded by the government for this
4 litigant to maintain contact with them. Because their administrat
5 ion- has chosen to warehouse me on the extreme end of the state,
6 it is clear they do not want me to have contact with legal
7 assistance, or family, or anyone outside.

8 FOR THE RECORD: The excessive penalties being charged by the
9 government's associates for kickbacks, has been effective in
10 keeping me from contacting anyone over the last sixteen years !.
