

Tri-County Communications, LTD (the "Company") hereby files this letter in lieu of the CPNI certification statement. The FCC previously determined in a December 2010 Order that licensees with non-interconnected, dispatch-only operations were not obligated to make a CPNI filing, and cancelled the related forfeiture issued for failure to make such a filing. The Company operates a non-interconnected, dispatch-only system identical to those licenses in the December Order. Accordingly, the Company believes it is not required to make an annual CPNI filing.
