**JOINT STATUS REPORT**

Pursuant to the July 1, 2014 Joint Motion to Hold Proceeding in Abeyance, which was granted on July 2, 2014, Commonwealth Telephone Company LLC d/b/a Frontier Communications Commonwealth Telephone Company (“Commonwealth”), CTSI LLC d/b/a Frontier Communications CTSI Company (“CTSI”), and UGI Utilities, Inc. – Electric Division (“UGI”) provide this update regarding the status of their negotiations.

On Friday, July 25, 2014, executives of Commonwealth, CTSI, and UGI met at the offices of Commonwealth and CTSI’s counsel in Washington, D.C. as part of a good-faith effort to resolve the issues raised by Commonwealth and CTSI’s Pole Attachment Complaint. Despite their efforts, the parties were not able to resolve their dispute or otherwise make sufficient progress to justify a further abeyance of this proceeding.


As a result, in accordance with the Bureau’s decision on the parties’ Joint Motion to Hold Proceeding in Abeyance, UGI’s Response to the Pole Attachment Complaint is due on or before August 25, 2014, and Commonwealth and CTSI’s Reply is due on or before September 15, 2014.
