
I, Paul Foxwell, Executive Vice President/General Manager, Allamakee-Clayton Electric Cooperative, Inc. ("Allamakee-Clayton"), being of lawful age and duly sworn, depose and state the following:

Pursuant to the Federal Communication Commission's *Rural Broadband Experiment Order*<sup>1</sup>, Allamakee-Clayton certifies it has obtained appropriate documentation from the Iowa Utilities Board to serve the areas for which it will receive support.

On March 5, 2015, Allamakee-Clayton obtained designation as an eligible telecommunications carrier (ETC) from the Iowa Utilities Board<sup>2</sup>.


On April 17, 2015, Allamakee-Clayton obtained certification as a telecommunications carrier in Iowa with the Iowa Utilities Board's issuance of a Certificate of Public Convenience and Necessity, identified as Certificate No. 0373.<sup>3</sup> Allamakee-Clayton certifies the accuracy of the information contained in both documents.<sup>4</sup>

I further state that I am authorized by Allamakee-Clayton to make this statement.


