Our television programs (WREG Channel 3, The WORD Network & Comcast Access Channel 17) are all entitled ***Touched by the Truth Ministries***. The lengths for our television programs that require closed captioning (WREG Channel 3, The WORD Network) are as follows:

WREG Channel 3:	58:30	1 program airs 52 weeks annually
The WORD Network:	28.30	1 program airs 52 weeks annually

Thank you for pointing out the error on the initial submission for the annualized amount for Caption Labs. The corrected annualized amount is \$26,104, as it also includes a delivery fee of \$130 x 52 weeks for both the :30m and 1:00h show.

Please find an additional quote we received from Vanan Captioning for \$34,398 annually (\$661.50 for both the :30m and 1:00h shows x 52 weeks).

We have not made any formal, written requests for sponsorship specifically to help offset any expenses incurred by closed captioning. We continue to invite our viewers and members to donate towards our outreach efforts, which include our on-air presence on the above mentioned programs.
