**MOTION TO STAY OR DISMISS**

Defendant Joseph T. Ryerson & Son, Inc., d/b/a Ryerson (“Ryerson”), respectfully moves to stay this case pending resolution of a petition by Ryerson to the Federal Communications Commission (“FCC”) seeking a retroactive waiver of the FCC’s opt-out requirements under the Telephone Consumer Protection Act, 47 U.S.C. § 227 (“TCPA”), for any faxes sent with the recipient’s consent. This matter should be stayed pending resolution of Ryerson’s petition because waiver from the FCC would fundamentally alter the manner in which this case proceeds.

Alternatively, even if this matter is not stayed, it should be dismissed because Ryerson has made an offer of more than complete relief to defendant Connector Castings, Inc. (“Connector”) that would more than satisfy its individual claims. The Court can dispose of this case now based on Ryerson’s offer by entering judgment in favor of Connector for the full amount of the offer and dismissing the class allegations without prejudice.

For the foregoing reasons, as set forth more fully in the accompanying Memorandum in Support, Ryerson requests that the Court enter an Order staying or dismissing this case.
