TRIBAL ENGAGEMENT

In accordance with 47 C.F.R. § 54.1004(d)(2) of the Commission's Rules, and as set forth in the attached certification, Smith Bagley, Inc. ("SBI" or "Company") notified the relevant Tribal governments in its winning bid service area within five business days (*i.e.*, no later than March 7, 2014) after being identified as a winning bidder in the Commission's February 28, 2014 Public Notice.¹ Specifically, the following Tribal government has been contacted: The White Mountain Apache Tribe (see letter attached herewith). In its outreach to this Tribal government, the Company indicated its willingness to engage in meaningful discussions regarding the deployment and improvement of communications on Tribal lands. In particular, SBI expressed its desire to discuss with the Tribal government: (1) a needs assessment and deployment planning with a focus on Tribal community anchor institutions; (2) feasibility and sustainability planning; (3) marketing services in a culturally sensitive manner; (4) rights of way processes, land use permitting, facilities siting, environmental and cultural review processes; and (5) compliance with Tribal business and licensing requirements.

To date, the Company has not received a response to its initial correspondence. However, the Company intends to follow up its correspondence with additional outreach to the White Mountain Apache Tribe, and it remains willing to discuss how the Company may play a role in the deployment and improvement of communications on Tribal lands.

In accordance the *Winning Bidders Public Notice* and the Commission's Rules, a copy of this Exhibit and the attached Certification is being provided to the White Mountain Apache Tribe concurrently with the submission of the Company's Long Form Application.²

FCC Form 690 - Construction Status

Smith Bagley, Inc. did not conduct any drive tests with respect to the SAC associated with this filing during the reportable period (November 20, 2014-December 31, 2014).

Smith Bagley, Inc.
Project Status Description

Pursuant to Section 54.1009(a)(6) of the Commission's rules,¹ Smith Bagley, Inc. ("SBI") submits the updates set forth below to its project description associated with this Study Area Code ("SAC") that was initially provided by SBI in its FCC Form 680 filed in conjunction with its Auction 901 winning bids.

In its FCC Form 680, SBI explained that in order to provide the most advanced wireless broadband service available to date, SBI is using the proceeds from auction 901 to expand its footprint with new cell sites. Specifically, use of support from Auction 902 will permit SBI to improve coverage to expand its 3G footprint and to cover operating and maintenance expenses expected in remote tribal areas that are not expected to be cash flow positive for many years, if ever. In many areas where Applicant currently serves, consumers have access to data speeds that are insufficient to stream high quality video and transmit large files without significant delay. Installation of 3G service will significantly increase data speeds. This will serve the public interest by allowing consumers to make more efficient use of smart phone devices, providing access to a wide variety of software applications. In every area where coverage is improved, rural citizens will see significant public safety benefits, as access to 911, E-911 and other important communications are all facilitated by improved connectivity in a mobile environment.

To date SBI had completed its network design, and has commenced construction of its network. However, for this census tract, SBI must construct new towers to expand its 3G services into the eligible areas within this census tract. SBI is still in the process of securing land

to allow them to construct the necessary towers. As the Commission is well aware, securing sites on tribal lands present significant additional challenges that have the potential to negatively impact the schedule of construction. Any activity relating to antenna structures on tribal lands could result in delay, due to approvals and coordination with tribal councils. In some instances, it can take two years or more to obtain all necessary approvals for sites on tribal lands.

Nonetheless, SBI anticipates that it will complete construction and deploy the network in the areas associated with this study code by no later than November 20, 2016.
