Dear Ms. Dortch,

This letter is submitted, pursuant to Section 1.1206(b)(1) of the FCC's rules, to notify you that representatives of the WMTS Coalition (the "Coalition") met July 29, 2015 in separate meetings with Commissioner Michael O'Rielly and his Legal Advisor Erin McGrath; and with Commissioner Ajit Pai and his Legal Advisor Brendan Carr. Attending those two meetings for the WMTS Coalition Tom Nickels, Senior Vice President, Federal Relations of the American Hospital Association; Dale Woodin, the Executive Director of the American Society for Healthcare Engineering; Erik Rasmussen Senior Associate Director, Federal Relations, for the American Hospital Association, Orrin Marcella, Government Affairs Executive for Coalition member GE Healthcare; Ari Fitzgerald (representing GE Healthcare), and the undersigned, counsel to the WMTS Coalition. Also on July 29, 2015, the WMTS Coalition met with Commissioner Mignon Clyburn and her Legal Advisor David Strickland. Representing the Coalition at that meeting were Linda Fishman, the Senior Vice President, Public Policy Analysis & Development of the American Hospital Association; Mr. Woodin; Mr. Rasmussen; Mr. Marcella; Mr. Fitzgerald (representing GE Healthcare); my partner, Bryan Tramont and the undersigned. Finally, on July 30, 2015, the Coalition spoke by telephone with Commissioner Jessica Rosenworcel and her Legal Advisor Johanna Thomas. On that call for the Coalition were Mr. Rasmussen, Mr. Marcella, Mr. Woodin and the undersigned.

At each of these meetings and the call, the Coalition sought each Commissioner's support for a three month delay in the Commission's consideration of technical rules to govern sharing of Channel 37 by unlicensed TV White Space devices, as requested in the Coalition's July 21, 2015 letter to Chairman Wheeler (a copy of which is on file in the above-referenced dockets). The Coalition also discussed in general terms the types of edits that might be made in the Report and

Order to allow for the requested delay without impacting any other decisions that might be reached in the Report and Order, or, as important, without in any way impacting the timing of the Incentive Auction. The Coalition also generally discussed the framework of discussions underway with representatives of the unlicensed device community (described in the July 21 letter) which would form the basis for an industry-wide resolution of those technical rules for the Commission's consideration, and reiterated concerns about the draft Report and Order, as reported in the press.
