On or around July 16, 2015, MyTeam1, LLC ("MyTeam1") submitted an Notice of Discontinuance of Service pursuant to Section 63.71 of the Federal Communications Commission's ("Commission") rules via the Commission's ECFS filing system. Subsequently, Commission staff recommended a revision to the customer notice to contain specific language relative to electronic filing of comments, as well as a statement concerning email service of the notices to customers. Dear Sir or Madam:

This letter is a reminder the MyTeam1 intends to discontinue the provision of telecommunications service effective August 25, 2015. YOU MUST ACT QUICKLY TO SWITCH YOUR SERVICES TO A NEW CARRIER.

Pursuant to 47 C.F.R. §§63.71, please find below the required information regarding the disconnection.

1. Name and address of carrier:

2. Date of planned service discontinuance, reduction or impairment:

August 25, 2015.

3. Points of geographic areas of service affected:

The states of Kentucky, Florida, New York, Ohio, Tennessee and Texas.

4. Brief description of type of service affected:

The Company will cease providing toll telecommunications services to its customers.

5. Date of Notice to Customers and Method of Service:

The notice will be sent to its customers on or about August 6, 2015 through electronic mail.

6. Type of carrier with respect to the service to be discontinued, reduced or impaired:

MyTeam is a non-dominant carrier reseller with respect to the service being discontinued.

The FCC will normally authorize this proposed discontinuance of service (or reduction or

impairment) unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the Commission's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the §63.71 Application of MyTeam1, LLC. Comments should include specific information about the impact of this proposed discontinuance (or reduction or impairment) upon you or your company, including any inability to acquire reasonable substitute service.
