Description of Reasonably Foreseeable Impact of the Planned Changes:

AT&T Southwest, Independent LECs, Wireless Service Providers, CLECs and Interexchange Carriers will be affected for traffic originating and terminating to and from end office (DLLSTXHACG0). All existing trunking to DLLSTXHACG0, with the **exception** of Direct Inward Dialing (DID) will need to be **migrated** to DLLSTXWH01T (Dallas Whitehall). DID will be served from the new remote location (DLLSTXHARPA). Independent LECs, Wireless Service Providers, CLECs and Interexchange Carriers must **(a)** determine whether to establish new trunk groups to DLLSTXRI01T, if appropriate, or handle the traffic at DLLSTXWH01T (Dallas Whitehall); and **(b)** evaluate whether their existing trunk groups to DLLSTXWH01T (Dallas Whitehall) are adequate to handle DLLSTXHARPA traffic. Access Service Requests (ASR) or Local Service Requests (LSR) will be due by **1/15/16**.
