**SUPPLEMENTAL SUBMISSION IN SUPPORT OF
ENFORCEMENT COMPLAINT**

On August 27, 2015, Hearst Properties Inc., a subsidiary of Hearst Television Inc. (collectively, "Hearst"), filed an Enforcement Complaint against Florida Cable Inc. ("Florida Cable") pursuant to Section 76.7 of the Commission's rules, 47 C.F.R. § 76.7, asserting that Florida Cable willfully violated Section 325(b) of the Communications Act of 1934, as amended ("the Communications Act"), 47 U.S.C. § 325(b)(1)(A), and Section 76.64 of the Commission's rules, 47 C.F.R. § 76.64(a), by retransmitting the signals of broadcast stations WESH(TV), Daytona Beach, Florida, WKCF(TV), Clermont, Florida, and WMOR-TV, Lakeland, Florida (collectively, the "Stations") without Hearst's consent or authorization.

Florida Cable did not answer or otherwise respond to the Complaint, either within the 20-day window established by Section 76.7(b)(2) of the Commission's rules, 47 C.F.R. § 76.7(b)(2), or thereafter. In fact, as of the date of this submission,¹ Florida Cable has not acknowledged the

¹ This submission is made on the date on which Hearst would otherwise have been permitted to reply had Florida Cable answered the Complaint. See 47 C.F.R. § 76.7(c)(3) (permitting replies to answers to be filed "within ten (10) days after submission of the responsive pleading"). Had Florida Cable responded to the Enforcement Complaint, its answer would have been due "within 20 days of service of the complaint," 47 C.F.R. § 76.7(b)(2)(ii). Hearst's Complaint was served on August 27, 2015, making Florida Cable's response due no later than September 16, 2015.

Enforcement Complaint at all, much as it failed to acknowledge or respond to Hearst's repeated requests that Florida Cable cease its unauthorized retransmission of Hearst's stations. See Enforcement Complaint ¶¶ 5-17.

Notwithstanding those repeated requests, and even in the face of the Enforcement Complaint, Florida Cable, upon information and belief, continues to retransmit the signals of the Stations without Hearst's authorization. See Exhibit A (attaching Florida Cable channel line-up for Astor/Volusia/Pierson, which lists WESH and WKCF, and the channel line-up for Oak Forest, which lists WMOR, printed September 28, 2015).

Given Florida Cable's continuing violation of Hearst's rights and its patent disregard for the Communications Act and the Commission's retransmission consent rules, Hearst respectfully urges the Commission to act expeditiously and order Florida Cable to cease immediately its unauthorized retransmission of the Stations' signals and take such other action as appropriate under the circumstances.
