On October 7, 2015, Mark Brunner, Senior Director, Global Brand Management, Ahren J. Hartman, Senior Director, Wireless Engineering, and Robert Szopko, Senior Engineer with Shure Incorporated (“Shure”) and Catherine Wang and Timothy L. Bransford of Morgan, Lewis & Bockius LLP met with Julius Knapp, Ira Keltz, Geraldine Matise, Paul Murray, Rashmi Doshi,¹ Serey Thai and Hugh Van Tuyl from the Office of Engineering and Technology.

During this meeting Shure discussed certain technical requirements recently adopted in the above proceedings affecting wireless microphones, including the Commission’s adoption of the European Telecommunications Standards Institute (“ETSI”) emission mask. Shure discussed action contemplated by the company to facilitate a smooth transition out of 600 MHz spectrum repurposed in the pending incentive auction while minimizing the impact on wireless microphone users. Shure also provided the Commission with a brief update on recent technical and operational developments that involve spectrum allocated for supplemental wireless microphone use in the above proceedings.
