Decision on Appeal: **Denied**
Explanation:

- Our records show that USAC issued you an Administrator's Decision on Appeal letter dated April 09, 2015. The record also shows that USAC informed you that since your appeal had been approved, but funding had been denied, you could

appeal the decision to USAC. Your appeal should have been postmarked within 60 days of the date on that letter. Your appeal for this decision was postmarked on June 09,2015. Although the Administrator's Decision letter considered this appeal untimely, it incorrectly specified the postmark date of that appeal as June 10, 2015. Since your appeal was in fact postmarked on June 09, 2015, and this is 60 days after the original appeal decision, your appeal is denied.

Since your appeal was denied in full, dismissed or cancelled, you may file an appeal with the FCC. Your appeal must be postmarked within 60 days of the date on this letter. Failure to meet this requirement will result in automatic dismissal of your appeal. You should refer to CC Docket No. 02-6 on the first page of your appeal to the FCC.
