
On behalf of TerraCom, Inc., and pursuant to section 64.1120(e) of the Commission's Rules, this is to notify the Commission of the upcoming transfer of the customers of YourTel America, Inc. ("YourTel") to TerraCom, effective on or about November 30, 2015. These affiliated companies, which provide wireless and wireline telecommunications services to qualified Lifeline customers and which already have substantially common ownership, plan to merge YourTel into TerraCom, such that the company will provide service under the TerraCom name in all the states previously served by YourTel, namely: Illinois, Kansas, Maine, Missouri, Oklahoma, Pennsylvania, Rhode Island, and Washington.

There will be virtually no impact on customers because there will be no change in any customer's rates, service plan or terms of service. The only change will be the change in the name of their provider to TerraCom. Copies of the notices that have been sent on or before October 30, 2015 to affected customers are attached hereto.
