We respectfully request a waiver of the rules regarding the deadline for filing the Funding Year 2014 Form 472 and submitting a Deadline Extension Request.


We unfortunately missed the October 28, 2015 deadline. We originally had more than one staff person managing the E-Rate submissions. Both left District employment and were replaced.

In all of these changes, the responsibility for the timely filings of the Form 472s was not securely assigned to any one person or firm.

We also request a favorable decision in light of the fact that this is our first experience with the new ruling making the filing of the Form 472 and the Invoice Deadline Extension requests coterminous.
