UPDATED RESPONSE TO REQUEST FOR INFORMATION FROM LEVEL 3 COMMUNICATIONS, INC.

1. Identify, for the month of August, 2015, the 20 U.S. Internet service providers to whom the Company delivered the highest rate of network traffic, as measured by the 95th percentile peak utilization.

Attachment 1 identifies the twenty U.S. ISPs that Level 3 interconnects with in the U.S. ranked by egress using the P95 methodology. Consistent with clarification from Commission staff on the definition of "U.S. Internet service providers," the twenty ISPs identified are U.S. providers of Broadband Internet Access Service, as that term is defined in 47 C.F.R. § 8.2(a).
