Respectfully Request for Waiver of Invoice Deadline

To whom it may concern,

Wayne County School District is respectfully requesting a waiver, to allow an invoice extension, for USAC (SLD) 472 (Bear Form) for the FRN's listed at the bottom of this document. Due to extenuating circumstances, the filing of 472's was after the deadline of 10/28/2015. In short, the district did not receive a 486 Notification Letter from USAC (a copy has been requested), transitioning of email contacts, transition to the EPC program by USAC, the delay of 2015-2016 FCDL's resulting in audits spanning the 472 submittal period, and other underlying factors attribute to those circumstances.


