
CERTIFICATION OF LIBERMAN BROADCASTING OF DALLAS LICENSE LLC

REIMBURSEMENT AGREEMENT

This Reimbursement Agreement (this "Agreement") is made and entered into this th 10 day of December, 2015, between Liberman Broadcasting of Dallas Licensee LLC ("Liberman") and Katherine Pyeatt ("Pyeatt"), as follows:

A. On October 29, 2015, Pyeatt submitted to the Federal Communications Commission ("FCC") a Petition for Rule Making in MB Docket 15-167 for changes to the FM Table of Allotments (the "Rule Making Proposal") to allot Ch. 286A to Grant, Oklahoma along with an application on Form 301 for that channel (BNPH-20141029ACJ) ("Pyeatt Application")

B. The Rule Making Proposal and Pyeatt Application conflicts with Liberman's pending application for a modification of facilities for Station KZMP-FM, Pilot Point, Texas to upgrade from Channel 285C1 to Channel 285C0 at a new transmitter site (BPH-20141028AAK) ("Liberman Application").

C. Pyeatt has agreed to accommodate the Liberman Application by withdrawing her Petition for Rule Making in MB Docket 15-167 and the Pyeatt Application ("Pyeatt Withdrawal"). To effectuate the withdrawal, Pyeatt is filing a Request for Approval of Withdrawal (the "Request") at the FCC.

D. In consideration of the Pyeatt Withdrawal and the Request, pursuant to Section 1.420(j) of the FCC's Rules, Liberman agrees to reimburse Pyeatt for her legitimate and prudent expenses.

E. Together, the grant of the Liberman Application and the Pyeatt Withdrawal will serve the public interest by providing better service to the public.

NOW THEREFORE, in consideration of the foregoing and the mutual covenants and agreements set forth herein, Liberman and Pyeatt hereby agree as follows:

1. Pyeatt's Obligations. Pyeatt agrees to withdraw her Petition for Rule Making in MB Docket No. 15-167 along with the Pyeatt Application, with prejudice. Pyeatt also agrees that she will not take any action to prevent, impede or delay the grant of the construction permit for the Liberman Application nor the license application to cover the Liberman Application.

2. Liberman's Obligations. Within five (5) days of the date that the FCC dismisses the Rule Making Proposal, Liberman shall transmit or cause to be transmitted a check to Pyeatt, at the address listed in the Certificate of Service, as reimbursement for Pyeatt's legitimate and prudent expenses as detailed in Exhibit A, attached hereto.


