Description of the Planned Network Change:

Verizon New York, Inc. will move all existing operator assistance, directory assistance, and call completion trunk groups from the Traffic Operator Position System (TOPS) switch (NYCMNY3707T) located at East 38th Street, New York, NY to the TOPS switch (NYCKNYWM09T) in Williamsburg, NY on or before May 31, 2016. Following completion of the re-home of trunk groups, the TOPS switch located at East 38th Street, New York, NY will be powered down, retired and physically removed.

Description of Reasonable Foreseeable Impact(s) of the Planned Change:

The following actions are required of any providers, including without limitation CLECs, IECs and Wireless Carriers meeting the criteria below that want to continue with existing operator assistance and directory assistance arrangements with Verizon:

- Carriers that currently send operator assistance and directory assistance traffic to the TOPS switch at East 38th Street New York, NY must establish new trunk groups or augment existing trunk groups

terminating in the TOPS switch in Williamsburg, NY and re-home operator assistance and directory assistance traffic to the trunk groups to the TOPS switch in Williamsburg, NY. Carriers currently receiving calls from the TOPS switch at East 38th Street, New York, NY must establish new trunk groups or augment existing trunk groups to the TOPS switch in Williamsburg, NY to continue receiving these calls after the re-home of trunk groups completes.

Access Service Requests (ASRs) for new trunk groups or additions to existing trunk groups required for the network change described above must be received no later than May 2, 2016. Once all the traffic has been migrated to the TOPS switch in Williamsburg, NY, ASRs to disconnect trunk groups from the TOPS switch at East 38th Street, New York, NY will be required. All ASRs associated with this project must carry the project code of "NYCMNY3707T".

Verizon Account Managers and the Verizon New York Engineering team will coordinate a kick-off conference call with each carrier during the first quarter of 2016. Please do not submit ASRs or re-route traffic until discussed with Verizon representatives.
