On behalf of Delta Telephone Co., Inc. ("Delta"), JSI respectfully submits this Amendment to the Delta 63.71 application to discontinue the provision of certain local operator services.<sup>1</sup> As noted in the Application, the single Louisiana exchange served by Delta is regulated by the Mississippi Public Service Commission. Delta deemed that notification to the Louisiana state commission and governor would cause undue confusion in that the four (4) Louisiana customers are regulated by the Mississippi Public Service Commission.

At the request of FCC staff, the Louisiana state commission and governor have been notified pursuant to § 63.71(a) of Commission rules by service of a copy of the Application.<sup>2</sup> Accordingly, please find attached an Amended Certificate of Service certifying to service of the Application on the Louisiana Public Service Commission and the Governor of Louisiana.


