Ladies/Gentlemen:

This is a letter of request to waive the deadline for the submission of an E-Rate Form 472.

For the last few months I have been dealing with several troubling health issues including, chronic obstructive pulmonary disease, anxiety disorder, and glaucoma, as well as experiencing difficulty tolerating various combinations of medicines which were being introduced to stabilize my conditions, but which ended up exacerbating my symptoms and seriously effecting my vision and ability to focus on my work.

Although it had never happened before in my four years of service as an E-Rate consultant, this year I made a mistake by checking off a 2014-15 Form 472 (BEAR Form) as having been completed, when in fact it had not. When I discovered this error, I immediately submitted a request for an invoice deadline extension, but being November 10, 2015 - it was already past the deadline and the request was denied.

I am requesting a waiver of the 472 invoice deadline be granted in this instance so that Toledo Central Catholic High School's already approved 2014-15 E-Rate application might not be denied because of my procedural error in requesting reimbursement, an error in which the school staff bore no responsibility.
