Attached please find AT&T's 2016 FCC Form 555 on behalf of the above referenced affiliated eligible telecommunications carriers ("ETCs").¹

The 2016 FCC Form 555 requires ETCs to report the number of subscribers claimed on its February 2015 FCC Form 497, among other data elements. In accordance with ¶ 17(a) of the Consent Decree in DA 15-485, in preparing the February 2015 Forms 497, AT&T performed its monthly statistically significant sample of the eligibility records for new Lifeline subscribers. In reviewing that sample, AT&T confirmed whether it had a complete, current, and accurate eligibility certification for each subscriber. AT&T also compared the sample to the NLAD database to confirm eligibility. In accordance with the Consent Decree, AT&T reduced the number of retail subscribers for whom it sought Lifeline reimbursement on its February 2015 FCC Forms 497 by applying the upper limit of the February 2015 weighted average error rates to the total number of retail subscribers. For this reason, the sum of the numbers reported in Block F and Block K of the AT&T affiliated ETCs FCC Forms 555 do not equal the numbers reported in Block E.

AT&T is providing this information by cover letter rather than on the affiliated ETCs FCC Forms 555 based on advice from USAC in 2014 that modifications on FCC or OMB approved forms without written approval from the Commission are not accepted. Both USAC and Commission staff had no objection to AT&T providing this information in a cover letter.


