Hi Karen,

It's actually standard that the internet service provider termination point, specifically when it's a County Office of Education, is on the contract and/or the bill. Charter is unique because they list the service locations on the bills but other carriers don't necessarily list out the addresses. However, if you look at AT&T contracts for districts that receive their internet from their County Offices, that contract will contain the address for the County office since that is the circuit they will receive internet traffic over.
