AT&T-12 State is announcing the removal of service and decommission of the Green Bay DCS located at the (GNBYWI01K02) serving wire center by 2nd Qtr 2016. All services on the Green Bay DCS will be migrated to the Green Bay DCS (GNBYWI01K01). This work will require any impacted Carriers to submit an ASR to AT&T Wisconsin.

Description of Type of Changes Planned:

This network change will move all services terminated on Green Bay DCS (GNBYWI01K02) to Green Bay DCS (GNBYWI01K01) by 2nd Qtr 2016.

Description of Reasonably Foreseeable Impact of the Planned Changes:
