
SUPPLEMENT TO APPLICATION

At the request of Commission Staff, the Application for Authority herein is supplemented as follows:

The service territories of The Middleburgh Telephone Company and Newport Telephone Company do not overlap, and are not contiguous. The distance between these service territories is approximately sixty miles.

A map showing the service territories of the two companies is attached. Middleburgh is #25 (light orange on color map) and Newport is #26 (dark orange). Middleburgh is in the 518 NPA, and Newport is in the 315 NPA.




