

I make this special request that this Petition for Reconsideration be accepted as filed within the 30 day deadline due to the following circumstances;

eRate 360 Solutions, LLC had recent staff changes which resulted in the change of duties. The company Vice-President Rich Larson, who for many years submitted all our client's appeals, retired on 1/31/16. This aspect of his duties was passed on to my portfolio. This is my first experience in filing an appeal on the Electronic Comment Filing System (ECFS) website. Due to my heavy workload in the middle of filing season for multiple client's FCC Form 471s and my lack of experience on the ECFS website, upon attaching the Gilroy_FCC-Petition_471-830048_Package.pdf to the site I saved a copy of the screen but omitted to click on the 'Confirm' button.
